Who can apply for summer aid at Salem State? You must be a matriculated student with a completed 2018-19 FAFSA that shows the Salem State University federal school code (#002188).

Return this application to the NavCenter (fax to 978.542.6876) or scan and email from your salemstate.edu account to navcenter@salemstate.edu.

If you wish to know your eligibility before classes begin please do these 3 things:

1. return this application by April 15 **AND**
2. be registered in ALL summer courses you intend to complete **AND**
3. complete all items on your Navigator To Do list.

Award notifications will begin May 1 via SSU email and continue throughout the summer.

It is important to note that financial aid funds are earned based upon days of attendance. Students not completing their summer courses will be subjected to the Return of Title IV policy resulting in loss of aid. This return calculation can occur AFTER summer classes have concluded and result in a balance due.

Are you making Satisfactory Academic Progress?

Summer aid awards may be processed before Spring 2019 grades are posted. Thus, if you are academically dismissed, or are not making Satisfactory Academic Progress at the end of Spring 2019, you will not be eligible for summer 2019 financial aid, *even if you had already been awarded summer aid by our office.*

If you are on ACADEMIC WARNING at the end of the Spring 2019, and you take summer courses:

- You must earn this SUMMER 2019 TERM and CUM GPA:
Undergraduate students: at, or above, 2.0
Graduate Students: at or above 3.0
- You must have a SUMMER 2019 TERM Completion Rate at, or above, 66% at the end of summer

Failure to achieve those requirements will result in Academic Probation and the loss of your financial aid for fall semester.

If you are on ACADEMIC PROBATION at the end of the Spring 2019, and you take summer courses:

- You must have completed an academic contract with Academic Advising if you are an undergraduate student or with your program coordinator if you are a graduate student
- You must have an approved Summer Financial Aid Appeal
- You must earn this SUMMER TERM and CUM GPA:
Undergraduate: at, or above, 2.0
Graduate students: 3.0 CUM GPA minimum
- You must have a SUMMER 2019 TERM Completion Rate at, or above, 66% at the end of summer

Failure to achieve those requirements: will result in contract violation, the loss of your financial aid eligibility at Salem State, and possible dismissal from the university.

Please Note: Due to their shortened length, summer courses can be rigorous and can very easily impact a student's academic standing. If you are on academic warning, or academic probation, it is strongly suggested that you discuss your plan for summer enrollment with an academic advisor.
