To easily complete the Data Transfer just log into your FAFSA and click on the secure IRS Data Retrieval tool located in the Financial Information Section.

If you are unable to do the IRS data transfer, you can request an IRS Tax Return Transcript or non filer statement online at www.irs.gov/Individuals/Get-Transcript or by calling the transcript order line at 800-908-9946.
